SURFACE PREPARATION

Concrete and Cement Floors

All surfaces must be cured according to the supplier's recommendations, minimum substrate cure is 28 days at 75°F. Concrete must be free of moisture as much as possible (moisture seldom drops below 15% in concrete). Test for moisture or dampness by taping the edges of a 2 foot by 2 foot plastic sheet on the bare surface (an asphalt tile or other moisture impervious material will also do), sealing all of the edges. After 48 hours, inspect for moisture, discoloration, or condensation on the concrete or the underside of the plastic. If moisture is present, the source must be located and the cause corrected prior to painting.

Remove all surface contamination by washing with ProClean Professional® Prep Wash Concentrated Cleaner or other appropriate cleaner, rinse thoroughly and allow to dry.

Scrape and sand existing peeled or checked paint to a sound surface. Sand glossy surfaces dull.

SURFACE PREPARATION

Remove all form release agents, curing compounds, salts, efflorescence, laitance, and other foreign matter by sandblasting, shotblasting, mechanical scarification, or suitable chemical means. Refer to ASTM D4260. Rinse thoroughly to achieve a final pH between 7.0 and 10.0. Allow to dry thoroughly prior to coating.

Surfaces must offer sufficient profile to achieve adequate adhesion. If the concrete feels like 120-grit sandpaper, the pores are open enough for this product to bond properly with the substrate. If the surface does not have this texture, etch the surface with H&C® Concrete Etching Solution first, following label directions. For very smooth surfaces (troweled surfaces with no porosity) use H&C Concrete Etching Solution at full strength. For smooth-troweled concrete with some porosity, 1 part H&C Concrete Etching Solution to two parts water should be used. Rough textured concrete does not need to be etched.

Do not etch painted surfaces.

Because water will collect in low spots and deposit etching and cleaning residue, it is recommended that the floor be vacuumed to remove any remaining water.

If surface deterioration presents an unacceptably rough surface, ArmorSeal 5020 Floor Resurfacer is recommended to patch and resurface damaged concrete.

Fill all cracks, voids and bugholes with ArmorSeal Crack Filler.

Wood

Sand to remove any loose or deteriorated surface wood and to obtain a proper surface profile. Patch all holes and imperfections with a wood filler or putty and sand smooth.

SURFACE PREPARATION

Steel

Remove rust and mill scale using sandpaper, steel wool, or other abrading method. Prime bare steel the same day as cleaned.

Slip Resistance

Some surfaces may require a slip resistant additive for safety. Add H&C SharkGrip® Slip Resistant Additive to the final coat applied following label directions. This product should not be used in place of a non-skid finish.

CLEANUP INFORMATION

Clean spills and spatters immediately with soap and warm water. Clean hands and tools immediately after use with soap and warm water. After cleaning, flush spray equipment with mineral spirits to prevent rusting of the equipment. Follow manufacturer's safety recommendations when using mineral spirits.
