Crystalline Silica (Quartz, Cristobalite) is listed by IARC and NTP. Long term exposure to high levels of silica dust, which can occur only when sanding or abrading the dry film, may cause lung damage (silicosis) and possibly cancer. Rats exposed to titanium dioxide dust at 250 mg./m3 developed lung cancer,

however, such exposure levels are not attainable in the workplace.
