

# ADD-2™

## Mildewcide Paint Additive

### Selection Data

**Generic Type** – Chlorothalonil-base, semi-liquid mildewcidal additive for paints and stains

**EPA Data** – Registered as a paint mildewcide with the U.S. Environmental Protection Agency. EPA Reg. No: 50534-197-71240. EPA Est. No: 71240-NJ-001. NOTE: IT IS A VIOLATION OF FEDERAL LAW TO USE THIS PRODUCT IN A MANNER INCONSISTENT WITH ITS LABELING.

### **Performance Characteristics**

- Interior and exterior use
- Effective, broad spectrum mildewcide
- Compatible with latex and alkyd paints or stains
- Will not affect color or performance of paint or stain
- Packaged in convenient 1.5 oz. and 7.5 oz. pouches for one gallon and five gallon applications

**Recommended Uses** – May be used in all types of interior and exterior paints, varnishes, and stains, including latex and alkyd coatings. Not recommended for low-solids systems such as conventional water sealers.

**Color** – Although ADD-2™ is light gray in color this will not affect the color of the paint or stain to which it is added

### Application Data

**Mixing** – Add *entire* contents of 1.5 oz. (44.4 ml) pouch to 1 gallon (3.8 liters) of paint or stain; add *entire* contents of 7.5 oz. (221.8 ml) pouch to 5 gallons (18.9 liters) paint or stain. Mix thoroughly into the paint or stain – if possible mechanically agitate or shake the container to ensure that ADD-2™ is thoroughly dispersed. Low viscosity systems such as semi-transparent stains and varnishes should be stirred frequently to prevent settling and ensure uniform application. ADD-2™ slightly diminishes the gloss of clear varnishes.

**Surface Preparation** – Surfaces to be painted must be clean, dry, and in sound condition. Wash thoroughly with detergent and water to remove dust, dirt, grime, and other contaminants that can interfere with paint adhesion. Rinse well and allow to dry before painting. Remove existing interior mildew with a cleaning solution formulated for this purpose. Kill exterior mildew with JOMAX® House Cleaner and Mildew Killer.



**Coating Application** – Apply coating according to manufacturer's directions

**Cleanup** – Clean up paint or stain spills and drips as directed by manufacturer. If ADD-2™ is spilled clean up immediately with a rag. (Wear plastic or rubber gloves to prevent contact of product with hands). Dispose of rag in manner prescribed below for empty container.

**Thinning** – Do not thin ADD-2™; add directly to paint or stain at container consistency. Thin paint or stain after ADD-2™ has been incorporated and only in accordance with coating manufacturer's directions.

### Limitations

ADD-2™ is not intended for use in any manner that is inconsistent with its labeling.

### Precautions

#### **Hazards to Humans and Domestic Animals.**

**DANGER** Corrosive. Causes severe eye damage and moderate skin irritation. Harmful if swallowed or inhaled. DO NOT get in eyes or on skin or clothing. Wear goggles or face shield, rubber gloves, long-sleeved shirt, and long pants when mixing this product. Wash thoroughly with soap and water after handling. Remove contaminated clothing and wash clothing before reuse. May be a skin sensitizer. Prolonged or frequently repeated skin contact may cause allergic reaction in some individuals. **Statement of Practical Treatment** - IF IN EYES: Hold eyelids open and flush with a steady, gentle stream of water for 15 minutes. IF ON SKIN: Wash thoroughly with plenty of soap and water. Get medical attention. IF SWALLOWED: Call a physician or poison control center. Drink promptly a large quantity of milk, egg white, gelatin solution, or, if these are not available, large quantities of water.

Avoid alcohol. NOTE TO PHYSICIAN: Probable mucosal damage may contra-indicate use of gastric lavage.

**Storage** - Store in a cool place. Protect from excessive heat. DO NOT store product after opening container. DO NOT contaminate food, water, or feed by storage or disposal.

**Disposal** – Use entire contents of **ADD-2™** package per label instructions. After emptying package securely wrap original container in several layers of newspaper and discard in trash. If waste product cannot be disposed of according to label instructions contact your State Pesticide or Environmental Control Agency, or Hazardous Waste Representative at the nearest EPA Regional office. Open dumping is prohibited. Pesticides wastes are toxic. Improper disposal of excess pesticide, pesticide formulation or rinsate is a violation of Federal law.

**Environmental Hazards:** This product is toxic to fish, aquatic invertebrates, and marine/ estuarine organisms. Do not discharge effluent containing this product into lakes, streams, ponds, estuaries, oceans or public sewers.
